Admissions requirements

We welcome applicants without traditional entry qualifications as we base decisions on our own assessment of qualifications, knowledge and previous work experience. We may waive formal entry requirements based on judgement of academic potential.

Requirement for those who have recently studied qualifications with a UCAS tariff equivalence : 112 UCAS tariff points/ A-levels (BBC).

- For mature students with experience: no specific A-level requirement. Admission is at the discretion of the admissions tutor.
- Certificate of Higher Education in Legal Methods (from Birkbeck): successful completion
 with a minimum mark of 50% enables entry to the LLB with optional credit for a first-year
 module
- Applicants may be required to complete a written exercise in reasoning and analysis if they
 do not meet UCAS tariff.
- Applicants are required to demonstrate that they meet the College's English language requirements.
- Credit for previous equivalent law studies may allow transfer into Year 2 at the discretion of the admissions tutor.

Foundation Year:

Foundation Year formal entry requirement to the LLB with Foundation year is at a level not higher than the standard Clearing entry of CCC equivalent and no lower than DD/DDE or equivalent. Non-traditional qualifications and/or paid/voluntary work or other relevant experience may be taken into account, as appropriate. All applicants will, in addition, be subject to test and interview.

48 UCAS points GCSE English and maths grade C or equivalent

The UCAS tariff score is applicable to you if you have recently studied a qualification that has a UCAS tariff equivalence. UCAS provides a <u>tariff calculator</u> for you to work out what your qualification is worth within the UCAS tariff.

Course aims

The LLB Law provides a comprehensive grounding in the seven foundational subjects of English law and extend students' legal knowledge and understanding in specialist areas through a broad range of research led teaching on optional modules. Students may also opt to graduate in one of our 3 pathways depending on the options they choose: LLB (Hons) in Law and Human Rights; LLB (Hons) in Law and Commercial Law; (LLB Hons) in Law and Legal Practice.

Professional Qualification

The programme satisfies the first stage (academic) of professional qualification laid down by the Bar Standard's Board (http://www.barstandardsboard.org.uk/) and the Solicitor's Regulation Authority (for those who began their degrees before 01 September 2022) (http://www.sra.org.uk/home/home.page). It also provides a foundation for the functional legal knowledge tested on the Single Qualifying Exam (Part One) set by the Solicitor's Regulatory authority.

Students who successfully complete study of the LLB Law are guaranteed progression to the University of Law, which provides short and long courses to prepare students for sitting the Single Qualifying Exam (parts one and two).

More specifically, the School of Law at Birkbeck aims to:

- Provide a comprehensive grounding in foundational subjects of English law and extend students' legal knowledge and understanding in specialist areas;
- Provide students with an understanding of major legal concepts, values, principles and rules of the legal system, legislation and case law;
- Provide students with extensive careers support and opportunities
- Provide a broad appreciation of the range of possible approaches to legal scholarship;
- Promote a multi-disciplinary approach to the study of law which enables students to make use of theoretical frameworks developed in law, the humanities and social sciences;
- Place the study of law within its historical, ethical, social, political, cultural and economic context;
- Provide students with a range of subject specific and transferable skills which develop their capacity to learn, meet the needs of the wider society and prepare students for employment or further studies.

Distinctive Features

The most distinctive feature of the LLB programme is that its structure of teaching is designed for students who need to balance study with paid work, family or other commitments but desire to study in an environment led by academic staff with extensive research expertise and publications in the field. Specific features include:

- Classes are standardly taught between 6pm and 9pm, Monday –Thursday
- Access to a full range of optional modules in the fields of human rights, criminal justice, commercial and legal practice as well as to a range of distinctive optional subjects relating to the research of academic staff.

Foundation Year Aims

- Provide directed and supervised learning opportunities that facilitate the development of study skills and enable students to prepare for undergraduate level study of law;
- Develop knowledge and understanding of defined areas of the legal system and introduce an awareness of current debates in those areas;
- Develop interpersonal and communication skills to clarify tasks, apply knowledge, and communicate outcomes in narrowly defined topics of legal study.

Distinctive features of Foundation Year

• The programme is ideal for recent school/college leavers who do not have either the requisite level 3 qualifications, or relevant work-related experience to make them eligible for entry to the standard LLB three year programme.

Pathway Degree Awards

Students who gain a required number of options from a pathway may choose to graduate with the relevant pathway title.

LLB (Hons) Law and Human Rights

Students on the LLB and LLB + FY would need to complete the Human Rights (30 Credits, Level 5 or 6) and 30 additional credits in optional modules classified as Human Rights modules.

LLB Law and Commercial Law

The LLB (Hons) in Law and Commercial Law offers students an opportunity to graduate with a qualification in an area of legal study that is popular amongst a significant number of our graduates. The pathway prepares students with a rounded set of core competencies, including the basics of company law, commercial law and broader modules in commercial law.

Students on the LLB and LLB + FY would need to complete 60 credits in designated Commercial Law optional modules. These include:

LLB Law and Legal Practice

The LLB Law and Legal Practice offers students an opportunity to graduate with a skills specific to legal practice; knowledge of specialised areas of legal practice; and broadly academic discourse on the professions.

Students on the LLB and LLB + FY would need to complete 60 credits in designated Legal Practice optional modules.

LLB Law with Environmental Studies

The LLB (Hons) Law with Environmental Studies offers students an opportunity to graduate with a minor in Environmental Studies. Students will be required to take Environmental Law (LALW025H5 or LALW035H6) and at least a further 75 credits from modules offered on the Environmental Studies Minor Pathway offer.

How you will learn

Your learning and teaching is organised to help you meet the learning outcomes (below) of the course. As a student, we expect you to be an active learner and to take responsibility for your learning, engaging with all of the material and sessions arranged for you.

Each course is divided into modules. You will find information on the virtual learning site (Moodle, see Academic Support below) about each of your modules, what to expect, the work you need to prepare, links to reading lists, information about how and when you will be assessed.

The School of Law employs a variety of teaching and learning strategies to enable learning outcomes to be achieved. In particular we promote student learning through lectures; seminars; virtual learning; private tutorials; web based independent skills tutorials; weekend and presessional skills workshops; public lectures and research seminars.

How we will assess you

Assessment is used to guide and promote your learning rather than simply to test it. The course uses a variety of different assessments across the modules you study, to help you develop the wide range of essential legal skills and abilities for the programme. Throughout your studies you will be assessed through a range of activities including:

- problem questions
- short critical essays
- seen and unseen exams
- legal research essays
- workbooks
- group projects
- oral presentations and discussions
- reflective writing
- multiple choice exercises
- critical thinking exercises
- focused legal skills exercises

Learning outcomes (what you can expect to achieve)

'Learning outcomes' indicate what you should be able to know or do at the end of your course. Providing them helps you to understand what your teachers will expect and also the learning requirements upon which you will be assessed.

Subject-specific skills

On successful completion of this course, you should be able to:

- Identify, explain and critically assess, orally and in writing, the main characteristics of the legal system, including general familiarity with its institutions and procedures
- Demonstrate a cogent and nuanced understanding of the detail of the law and its context, in and beyond the seven foundational subjects: Constitutional and Administrative Law, Contract Law, Criminal Law, Tort, Law, Property Law, Equity and Trusts, and Law of the European Union
- Interpret, analyse and apply legal rules and principles, orally and in writing, to factual scenarios
- Distinguish between strong and weak arguments, and evaluate the strength of legal argumentation in decided cases and academic commentary
- Identify, retrieve and use legal sources and sources of academic commentary selectively and judiciously, including the ability to distinguish between authoritative legal and scholarly sources and unreliable sources
- Interrogate these materials in terms of their legal meaning, authority and effects in different contexts. This may include empirical, analytical, and/or theoretical methods, and/or the critical apprehension of methods for understanding legal knowledge and techniques
- Demonstrate knowledge, understanding and critical analysis of a range of legal concepts, values, principles and rules, and an ability to explain the relationships between them in a number of particular areas
- Identify and demonstrate depth of knowledge of some of the political, economic, commercial, social and cultural factors that inform and underlie legal theory and doctrine
- Understand and explain complex aspects of the problems, tensions and contradictions within certain legal theories and doctrines
- Identify and critically analyse contemporary public and scholarly debates about legal issues
- Compose cogent argumentative analyses of and arguments about the law in writing that is clear, well-reasoned and persuasive
- Expound and defend cogent arguments about the law in oral communication that is clear, well-reasoned, confident and persuasive
- Apply the above abilities independently in spontaneous written and oral communication including in time-constrained contexts
- Conduct in-depth legal research on specific legal topics that demonstrates legal and scholarly understanding and judgment

- Write in-depth, well-composed legal analyses which exhibit detailed legal scholarship and clear, well-reasoned and persuasive argumentation
- Defend, elaborate and interrogate arguments about law in spontaneous oral dialogue, in a way that is clear, well-reasoned, confident and persuasive
- Display appropriate independence, agility and depth of thought in respect of the above abilities and contexts

General/transferable skills and capacities that are essential to law

On successful completion of the course, you will have developed the following:

- Intellectual independence, including the ability to ask and answer cogent questions, identify gaps in their knowledge and acquire new knowledge, and engage in critical analysis and evaluation
- Problem-solving, including initiative, imagination and pragmatic judgment
- Adeptness in conducting independent research, including accurate recognition of issue(s), the identification, retrieval and evaluation of accurate, current and relevant information from a diverse range of appropriate sources, and their appropriate application
- Ability to work with a range of data, including textual, numerical and statistical
- Clear, effective and precise oral and written communication in responding
- appropriately and sensitively to a range of differing positions and arguments
- Digital literacy in finding, managing, creating and communicating information, including the informed and judicious use of emerging AI tools
- Self-management, including an ability to reflect on their own learning, make effective use of feedback, a willingness to listen to advice and to acknowledge and correct errors
- Willingness and ability to work collaboratively
- Engagement with their own personal and professional development, including appreciation of the core values of professional honesty and academic integrity
- Understanding of ethical conflicts that may arise and how to make reasoned, balanced judgements to resolve them
- Development of personal integrity and an awareness of the potential ethical impacts of decision-making

Birkbeck will introduce you to the Library and IT support, how to access materials online, including using Moodle, and provide you with an orientation which includes an online Moodle module to guide you through all of the support available. You will also be allocated a personal tutor and provided with information about learning support offered within your School and by the College.

Quality and standards at Birkbeck

Birkbeck's courses are subject to our quality assurance procedures. This means that new courses must follow our design principles and meet the requirements of our academic regulations. Each new course or module is subject to a course approval process where the proposal is scrutinised by subject specialists, quality professionals and external representatives to ensure that it will offer an excellent student experience and meet the expectation of regulatory and other professional bodies.

You will be invited to participate in an online survey for each module you take. We take these surveys seriously and they are considered by the course team to develop both modules and the overall courses. Please take the time to complete any surveys you are sent as a student.

We conduct an annual process of reviewing our portfolio of courses which analyses student achievement, equality data and includes an action plan for each department to identify ongoing enhancements to our education, including changes made as a result of student feedback.

Our periodic review process is a regular check (usually every four years) on the courses by department with a specialist team including students.

Each course will have an external examiner associated with it who produces an annual report and any recommendations. Students can read the most recent external examiner reports on the course Moodle pages. Our courses are all subject to Birkbeck Baseline Standards for our Moodle module information. This supports the accessibility of our education including expectations of what information is provided online for students.

The information in this programme specification has been approved by the College's Academic Board and every effort has been made to ensure the accuracy of the information it contains.

Programme specifications are reviewed periodically. If any changes are made to courses, including core and/or compulsory modules, the relevant department is required to provide a revised programme specification. Students will be notified of any changes via Moodle.
