Admissions requirements

We welcome applicants with a wide range of previous experience and qualifications. A second class honours degree (2.2 or above) in a Humanities or Social Sciences subject satisfies the standard requirement, but we do base decisions on our own assessment of qualifications, knowledge and previous work experience. We may request writing samples or further interview to gauge academic potential in instances where non-traditional education and experience may merit the waiving of formal entry requirements.

Course aims

The MA/MSc Gender and Sexuality Studies is built around the interdisciplinary study of gender and sexuality across multiple sites of power. This course is ideal if you are interested in how gender and sexuality are shaped, understood and represented in different historical, cultural, geographic and social contexts. We bridge the divide between the social sciences and the arts and humanities by offering an MSc and MA. The MA modules allow you to explore aspects of gender and sexuality in literature, history, media and film, visual art, philosophy and cultural theory. The MSc modules allow you to explore the diverse and changing nature of gender and sexuality in social relationships, economics and the workforce, development and legal studies.

The course explores current debates in gender and sexuality studies and incorporates the research of world-leading academics at Birkbeck, who are passionate and engaged in the real world, working towards social justice with activists, policy-makers, academics, and charities and NGOs. You will find yourself in seminar rooms with a diverse range of people, from many different backgrounds and careers, generating a lively, engaged and enthusiastic learning environment. Whether you choose online, in-person or hyflex study, you will build a deeper understanding of the field and join a vibrant community of scholars driving change and challenging norms.

You will consider competing ideas and theories about gender and sexuality and explore the ways in which these intersect with concepts of race, ethnicity, age and class. The course will develop your ability to critically discuss these theories and to consider how the arts, humanities and social sciences can help us understand gender and sexuality.

This firm grounding in theories of gender and sexuality, along with research skills preparation, will help you develop the confidence you need to undertake an independent research project in the area that most interests you.

Degree qualification of MA or MSc

Bridging the divide between the Arts, Humanities and Social Sciences, our interdisciplinary programme enables you to tailor your study to your interests, passions and goals, working toward the award of MA or MSc.

All applicants to the programme will be initially enrolled on the joint MA/MSc programme but can opt to graduate with an exit award of the MA or MSc degree, depending on the selection of modules and dissertation topic.

To graduate with the **MA degree**, students must:

• Complete a minimum of 60 options credits in Arts and Humanities credits, and/or focus their dissertation topic using an Arts & Humanities approach.

To graduate with the **MSc degree**, students must:

• Complete a minimum of 60 options in Social Science credits and/or focus their dissertation using a Social Sciences approach.

If you have a preference of which degree you wish to complete and are unsure which options modules are classified as Arts, Humanities or Social Sciences, you should consult with the Programme Director before selecting your options.

Postgraduate Diploma or Postgraduate Certificate

Student who wish to complete a shorter programme without a dissertation can opt for the Postgraduate Diploma (120 credits) or Postgraduate Certificate (60 credits).

How you will learn

Your learning and teaching is organised to help you meet the course learning outcomes (below). As a student, you are expected to be an active learner and to take responsibility for your learning, engaging with all the material and sessions arranged for you.

Each course is divided into modules. You will find information on the virtual learning site (Moodle, see Academic Support below) about each of your modules, what to expect, the work you need to prepare, links to reading lists, information about how and when you will be assessed.

Your learning for this course will be organised around the activities outlined below.

Teaching on this course includes lectures but is predominantly structured as seminars, or discussion-focused group sessions. The introductory module Theorising Gender and Sexuality, includes lectures from internationally recognised staff working in feminism and gender studies, LGBTQ+ history and activism, queer theory, and histories of medicine, sexology, psychiatry and psychoanalysis. This module will introduce you to the relationship between theory and methodology in Gender and Sexuality Studies.

Seminars in Theorising Gender and Sexuality and in subsequent modules will train you in the construction of collaborative knowledge alongside the diverse community of your fellow students. You will also deepen your subject knowledge and sharpen your critical skills through extensive reading and other forms of independent learning.

Modules across the programme include the analysis of primary and secondary text sources, as well as of images, material culture, music and film.

Most option modules are delivered in-person, some are delivered both in-person and online, and some online only. There is sufficient online provision to allow students to complete their degrees with no in-person modules. Those students taking the online route through the programme, or who select one or more of the online modules as part of their studies, will be taught through a mixture of online seminars, live and recorded lecture material, and a range of additional online resources.

How we will assess you

The course uses a variety of assessment methods. Assessment is used to enhance your learning rather than simply to test it. For most of the modules associated with this course, your assessment will be through the following types of assessment.

Humanities and social science modules normally incorporate diverse forms of assessment, including shorter, mid-term written exercises such as source analyses or literature reviews; oral presentations; and end-of-module research essays. Assignments grow in complexity across the term, offering the reassurance of guided progression towards the research essay, and tailored writing support is available within the department and at college level for students who might benefit from additional advice. To complete the degree, you will design, research, and write a dissertation. The dissertation research training module will support you in developing your research skills, undertaking a literature review and preparing a research proposal, followed by completion of the dissertation.

Learning outcomes (what you can expect to achieve)

'Learning outcomes' indicate what you should be able to know or do at the end of your course. Providing them helps you to understand what your teachers will expect and also the learning requirements upon which you will be assessed.

At the end of this course, you should be able to:

- Convey a critical awareness of theoretical issues at stake in gender and sexuality scholarship in the arts, humanities and/or social sciences
- Critically appraise and apply different methodologies used in the analysis and interpretation of gender and sexuality in the arts, humanities and/or social sciences
- Engage with interdisciplinary and cross disciplinary debates in gender and sexuality studies
- Critically discuss texts, objects and diverse media with a group of your peers
- Present your own research and arguments orally
- Design your own research questions and programme of research
- Carry out research and writing at multiple scales: response essay, research essay, dissertation
- Demonstrate skills to design and create disseminations of your research in multiple forms (e.g. article, podcast or public talk)

Careers and further study

The MA/MSc Gender and Sexuality Studies prepares you for any role which benefits from skills in research, communication and engagement. Graduates of our programme are employed in sectors directly connected to gender and sexuality issues, from social work to nongovernmental and charitable organisations, from journalism to government and policy research, but some work across a wider range of professions and disciplines, from education to business to the arts. Graduates interested in further study have gone on to complete research degree (MPhil/PhD) programmes.

Birkbeck's MA/MSc Gender and Sexuality Studies graduates will complete with a set of valuable attributes, for example:

- The ability to work as part of a team
- High-level oral and written communication skills in English
- Research skills

- Skills in evaluating and assessing types of information
- The ability to present yourself and an argument to a range of audiences

You will also be allocated a personal tutor and provided with information about learning support offered within your School and by the College.

Quality and standards at Birkbeck

Birkbeck's courses are subject to our quality assurance procedures. This means that new courses must follow our design principles and meet the requirements of our academic regulations. Each new course or module is subject to a course approval process where the proposal is scrutinised by subject specialists, quality professionals and external representatives to ensure that it will offer an excellent student experience and meet the expectation of regulatory and other professional bodies.

You will be invited to participate in an online survey for each module you take. We take these surveys seriously and they are considered by the course team to develop both modules and the overall courses. Please take the time to complete any surveys you are sent as a student.

We conduct an annual process of reviewing our portfolio of courses which analyses student achievement, equality data and includes an action plan for each department to identify ongoing enhancements to our education, including changes made as a result of student feedback.

Our periodic review process is a regular check (usually every four years) on the courses by department with a specialist team including students.

Each course will have an external examiner associated with it who produces an annual report and any recommendations. Students can read the most recent external examiner reports on the

course Moodle pages. Our courses are all subject to Birkbeck Baseline Standards for our Moodle module information. This supports the accessibility of our education including expectations of what information is provided online for students.

The information in this programme specification has been approved by the College's Academic Board and every effort has been made to ensure the accuracy of the information it contains.

Programme specifications are reviewed periodically. If any changes are made to courses, including core and/or compulsory modules, the relevant department is required to provide a revised programme specification. Students will be notified of any changes via Moodle.
