Admissions requirements

Undergraduate degree at 2nd class honours or above, and/or relevant practical experience in the creative industries. If English is not your first language or you have not previously studied in English, the requirement for this programme is the equivalent of an International English Language Testing System (IELTS Academic Test) score of 6.0, with not less than 6.5 in each of the sub-tests.

We welcome applicants without traditional entry qualifications as we base decisions on our own assessment of qualifications, knowledge and previous work experience. We may waive formal entry requirements based on judgement of academic potential.

Course aims:

Birkbeck's MA Theatre and Performance is a highly distinctive degree delivered by one of the most impactful and innovative departments in the UK. Taught by world-leading academic researchers, writers, dramaturgs, and theatre makers, in association with industry artists and partners, you will explore the dynamic relationships between text, performance, writing, and dramaturgy through a combination of:

- Writing for and about theatre and performance
- Performance-making
- Dramaturgical practice
- Academic study
- Playwriting

This postgraduate degree is ideally suited to those interested in learning about or working in theatre and the performing arts, including writing for performance, digital and screen-based arts, dramaturgy and literary management, and an array of other career paths. Each student will choose between three specialist routes upon application. The degree titles you can exit with upon graduation are one of the following:

- Theatre and Performance: Theatre Making
- Theatre and Performance: Dramaturgy
- Theatre and Performance: Writing for Performance

Students across all three routes will share some compulsory modules in which you will examine historical, philosophical and theoretical materials and ideas to understand contemporary theatre and performance and the ways in which they are shaped by current concerns, traditions, and legacies. Depending on your chosen exit award you will also study with industry professionals at Camden People's Theatre (Theatre Making), leading playwrights and screenwriters such as David Eldridge and Daragh Carville (Writing for Performance), and guest artists such as Tim Crouch and Zoe Svendsen (Dramaturgy). This course will prepare you to enter the world of creative industries with specialist theoretical and practical knowledge, and an informed overview of the creative process and its components.

How you will learn

Your learning and teaching is organised to help you meet the learning outcomes (below) of the course. As a student, we expect you to be an active learner and to take responsibility for your learning, engaging with all of the material and sessions arranged for you.

Each course is divided into modules. You will find information on the virtual learning site (Moodle, see Academic Support below) about each of your modules, what to expect, the work you need to prepare, links to reading lists, information about how and when you will be assessed.

Your learning for this course will be organised around: individual and collaborative project work; independent and in-class activities; critical engagement with a variety of dramatic, writing workshops, performative and theoretical texts and performances; written and performed tasks; academic inquiry and performance-making.

Teaching on this course is a combination of lectures, seminars and studio-based practices. Lectures are designed to provide you with an outline or overview of the topic, to engage you with the material and direct you to other resources. They are a springboard for your own learning. Seminars are group sessions where you will be asked to contribute to discussion or group work around the topic, with material set in advance for which you need to prepare. Studio-based workshops provide you with the opportunity to explore practices and ideas in embodied ways, and to refine your performance-making and presentation skills.

How we will assess you

The course will use a variety of assessment methods. Assessment is used to enhance your learning rather than simply to test it. For most of the modules associated with this course, your assessment will be through the following types of assessment.

Assessment methods include:

- Research essays
- Creative projects, practice, and portfolios
- Critical reflections on practical work
- In-class performance exercises (Theatre and Performance)
- Scriptwriting (Writing for Performance)
- Dissertations (practice-led or academic pathways)

Learning outcomes (what you can expect to achieve)

'Learning outcomes' indicate what you should be able to know or do at the end of your course. Providing them helps you to understand what your teachers will expect and also the learning requirements upon which you will be assessed.

At the end of this course, you should be able to:

- Show a creative and conceptual understanding of theatre and performance-making
 processes that will support the critical evaluation of current research, performance and
 advanced scholarship in the discipline. This will enable students to evaluate and critique
 rival methodologies, and, where appropriate, develop and propose new hypotheses and
 practices;
- 2. Demonstrate a systematic understanding of performance practice and a critical awareness of the current problems and new insights raised by the relationship between history, theory and practice;

- 3. Identify, engage and analyse a variety of approaches to the creation of text and performance that inform contemporary theatre practice;
- 4. Show an ability to develop practice-based approaches to a range of theatrical, dramatic and performative stimuli and sources.
- 5. Evidence an ability to work through complex ideas intellectually and creatively, make sound judgements in the absence of complete data, and communicate conclusions clearly to specialist and non-specialist audiences;
- 6. Demonstrate originality in the application of knowledge and the development of practice based projects, together with a practical understanding of how established techniques of research, enquiry and performance are used to create and interpret knowledge;
- 7. Deal with complex issues both systematically and creatively, make sound judgements in the absence of complete data, and communicate their conclusions clearly to specialist and nonspecialist audiences; [Social/practical]:
- 8. Demonstrate self-direction and originality in tackling and solving problems and act autonomously in planning and implementing tasks at a professional or equivalent level;
- 9. Manage workloads and meet deadlines;
- 10. Evidence a capacity to work collaboratively in a small group to achieve shared goals;
- 11. Develop transferable skills of value within and beyond the subject including: interpersonal and communication skills; creative thinking and problem solving; initiative and personal responsibility; decision-making in complex and unpredictable situations; and the independent learning ability required for continuing professional development.

Quality and standards at Birkbeck

Birkbeck's courses are subject to our quality assurance procedures. This means that new courses must follow our design principles and meet the requirements of our academic regulations. We conduct an annual process of reviewing our portfolio of courses which analyses student achievement, equality data and includes an action plan for each department to identify ongoing enhancements to our education, including changes made as a result of student feedback.

Our periodic review process is a regular check (usually every four years) on the courses by department with a specialist team including students.

Each course will have an external examiner associated with it who produces an annual report and any recommendations. Students can read the most recent external examiner reports on the course Moodle pages. Our courses are all subject to Birkbeck Baseline Standards for our Moodle module information. This supports the accessibility of our education including expectations of what information is provided online for students.

The information in this programme specification has been approved by the College's Academic Board and every effort has been made to ensure the accuracy of the information it contains.
