## Admissions requirements

Usually, we require a high 2:1 or above for your undergraduate degree and a merit for your master's. At least one of your previous degrees should be in an area relevant to your proposed research.

## Course aims

The MPhil/PhD in Management aims to train you to conduct research of a high academic standard and to make an original contribution to the subject through your thesis. It involves taught coursework and research training, and will not only prepare you to undertake research for your own dissertation, but will also equip you to be able to evaluate research results and reports more widely.

## Course structure

In the first year of the MPhil/PhD program (first two years, if part-time), you take research training modules, review the academic literature in your field, and prepare a detailed plan for your research. Then, in the second and third years (full time) or third-fifth years (part time), you complete a substantial independent research project, and write your PhD thesis. The subject matter might be anything falling within the research competencies of the Department of Management.

In the first year (both full-time and part-time) you are required to take four modules for credit. Ordinarily they are the following, although permission to substitute alternate research training modules may be granted:

BUMN112H7 Research Philosophy  
MOMN040H7 Organization Theory  
BUMN071H7 Quantitative Methods for Finance  
MOMN020H7 Qualitative Research Methods

In the first year (FT) or second year (PT), you write a Research Prospectus (BUMN098D7), which includes a preliminary literature review and a plan for their thesis research.

Upon satisfactory completion of the modules and Research Prospectus, your primary responsibility is research and writing for your PhD thesis.

### **Exemptions:**

Students may: be awarded exemptions against any of these modules; be allowed to substitute other modules or have their programme altered to support their study/research needs as agreed by the programme director.

### **Exit awards:**

To exit this programme with an **MRes Business Research degree** requires 180 level 7 credits, and students will need to take BUMN099D7 MRes Dissertation (Short) in place of the PhD thesis to obtain this award.

To exit with a **PG Dip Business Research** or **PG Cert Business Research** requires achievement of 120 and 60 credits respectively in line with CAS regulations.

### **How you will learn**

Your learning and teaching is organised to help you meet the learning outcomes (below) of the course. As a student, we expect you to be an active learner and to take responsibility for your learning, engaging with all of the material and sessions arranged for you.

Each course is divided into modules. You will find information on the virtual learning site (Moodle, see Academic Support below) about each of your modules, what to expect, the work you need to prepare, links to reading lists, information about how and when you will be assessed.

Your learning for this course will be organised around the activities outlined below.

There are some taught modules with teaching in the form of lectures (pre-recorded) and seminars; but the programme is primarily, independent research supervised by members of academic staff.

### **How we will assess you**

The course will use a variety of assessment methods. Assessment is used to enhance your learning rather than simply to test it. For most of the modules associated with this course, your assessment will be through the following types of assessment. essays; research projects, coursework, tests, and exams

## **Learning outcomes (what you can expect to achieve)**

'Learning outcomes' indicate what you should be able to know or do at the end of your course. Providing them helps you to understand what your teachers will expect and also the learning requirements upon which you will be assessed.

At the end of this course, you should be able to:

- Demonstrate expertise in particular set of social science research methods,
- Demonstrate expertise in a particular subject area related to business or management; specifics depend on the individual project.
