## Admissions requirements

Usually a second-class honours degree in a subject related to management, finance or business related studies. We also welcome students from other social sciences, i.e. history, sociology, law, political science, linguistics, media studies, psychology.

We also welcome professional or other qualifications obtained by written examinations approved by the College. Relevant experience, supporting statements and references may be taken into consideration, especially in the case of non-standard applications.

We welcome applicants without traditional entry qualifications as we base decisions on our own assessment of qualifications, knowledge and previous work experience. We may waive formal entry requirements based on judgement of academic potential.

## International entry requirements

If English is not your first language or you have not previously studied in English, our usual requirement is the equivalent of an International English Language Testing System (IELTS Academic Test) score of 6.5, with not less than 6.0 in each of the sub-tests.

If you don't meet the minimum IELTS requirement, we offer pre-sessional English courses, foundation programmes and language support services to help you improve your English language skills and get your place at Birkbeck.

## Course aims

MSc Management and Finance is an inspiring programme that will provide students with up-to-date topics in management and empirical finance. If students are interested in a career in investment, financial institutions, or any other financial management related jobs, then this programme equips students with the required knowledge and skills. The syllabus of this programme is specifically designed to equip quantitative analysis skills, to advance applied financial management abilities, to critically analyse financial proposals and empirical applications of corporate finance.

## Course structure

Students take eight 15-credit compulsory modules plus a 12,000-word dissertation on any area of management and finance.

### How you will learn

A 3-hour lecture each week aims to introduce students to the particular topic as well as to encourage them to get the required knowledge of the specific finance/investment area.

Consistent with the higher education at postgraduate level, lectures introduce and highlight the material but are not aimed to cover all the aspects related to the topic. Students are expected to read and prepare for lectures and to discuss whatever is necessary in the class.

The second part of the lecture is a seminar designated to solve questions or discuss cases or empirical studies related to the area of interest. Students are asked to prepare for these materials so they can engage with lecturer.

### How we will assess you

The course will use a variety of assessment methods. Assessment is used to enhance your learning rather than simply to test it. For most of the modules associated with this course, your assessment will be through the following types of assessment.

Short written exercises, essays which will develop in length and expected complexity as you progress through your studies, quizzes and multiple-choice questionnaires, practical assessments (of your work in a lab/studio), case studies, problems to solve.

## **Learning outcomes (what you can expect to achieve)**

### **Knowledge and understanding:**

Upon completion, this programme aims to:

1. Provide students with a management and finance specialisation.
2. Understand the major aspects related to financial management, financial reporting, small business finance, financial modelling, and international finance.
3. Understand the applied financial management tools used by firms and financial markets participants.

### **Intellectual, practical, and transferable skills:**

Students will gain the following skills upon completing this programme:

1. The required the skills to critically analyse contemporary issues of management and finance.
2. The required skills to analyse financial data using the specialized financial modelling techniques will be developed.

Financial and management professionals in all businesses, including the financial industry.

Birkbeck's MSc Management and Finance graduates will complete with a set of valuable attributes, for example:

## Quality and standards at Birkbeck

Birkbeck's courses are subject to our quality assurance procedures. This means that new courses must follow our design principles and meet the requirements of our academic regulations. We conduct an annual process of reviewing our portfolio of courses which analyses student achievement, equality data and includes an action plan for each department to identify ongoing enhancements to our education, including changes made as a result of student feedback.

Our periodic review process is a regular check (usually every four years) on the courses by department with a specialist team including students.

Each course will have an external examiner associated with it who produces an annual report and any recommendations. Students can read the most recent external examiner reports on the course Moodle pages. Our courses are all subject to Birkbeck Baseline Standards for our Moodle module information. This supports the accessibility of our education including expectations of what information is provided online for students.

The information in this programme specification has been approved by the College's Academic Board and every effort has been made to ensure the accuracy of the information it contains.
