### How you will learn

Your learning and teaching are organised to help you meet the learning outcomes (below) of the course. As a student, we expect you to be an active learner and to take responsibility for your learning, engaging with all of the material and sessions arranged for you.

Each course is divided into modules. You will find information on the virtual learning site (Moodle, see Academic Support below) about each of your modules, what to expect, the work you need to prepare, links to reading lists and readings, and information about how and when you will be assessed.

Teaching on this course is a combination of in-person lectures and seminars. Lectures are designed to provide you with an outline or overview of the topic, to engage you with the material and direct you to other resources. They include interaction with the lecturer and are a springboard for your own learning. Seminars are group sessions where you will be asked to contribute to discussion around the topic, with material set in advance for which you need to prepare. In addition to attending lectures and seminars, you will engage in substantial independent learning during this course, including reading texts in philosophy; answering questions about the texts in preparation for participation in classes; watching/listening to audio-visual resources; completing assessments. Introduction to Philosophy seminars occur twice a week, while seminars/classes in all other modules occur once a week.

### How we will assess you

The course will use a variety of assessment methods. Assessment is used to enhance your learning rather than simply to test it. For most of the modules associated with this course, your assessment will be through essays, which will develop in length and expected complexity as you progress. Some modules may have short writing assignments, short-answer exams (completed at home) or sets of problems to solve.

### Learning outcomes (what you can expect to achieve)

'Learning outcomes' indicate what you should be able to know or do at the end of your course. Providing them helps you to understand what your teachers will expect and also the learning requirements upon which you will be assessed.

At the end of this course, you should be able to:

- Demonstrate a systematic understanding of some central areas of philosophy, including historical and contemporary debates
- Display a thorough understanding of different ideas, contexts and frameworks deployed by philosophers in particular debates, and their strengths and weaknesses
- Develop critical responses to different philosophical arguments and theories, suggesting new approaches

- Flexibly and creatively apply knowledge to critically challenge philosophical responses to key arguments
- Understand and communicate complex ideas and information at a high level of abstraction
- Construct detailed, complex arguments for thought-out positions which appropriately deploy advanced philosophical methodologies
- Demonstrate a capacity for original and independent thought while developing the capability to effectively communicate in a range of contexts
- Autonomously implement and evaluate improvements to performance, taking into account reflection, feedback and philosophical best practice

### **Careers and further study**

Graduates can pursue career paths in education, research, politics and journalism. Possible professions include:

- Higher education
- Civil service
- Local government officer
- Journalist
- Business and finance
- Social work
- Marketing and advertising

### **Quality and standards at Birkbeck**
