# <sup>14</sup> Programme Rationale & Aims

Taking the dramatic text as a critical starting point, MA Text and Performance sets out to explore theatre and performance through both practice and scholarship. Drawing on theoretical, historical, critical and philosophical literatures in theatre and performance studies, the programme examines contemporary theatre and performance, and the ways in which new work is informed by both contemporary concerns and older theatre traditions and legacies. In the rehearsal room, the programme mobilises techniques of voice, movement, playwriting, directing and dramaturgy to create new theatrical work that responds to set texts and themes. Equal weight and class-time is given to practical theatremaking and scholarly examination of theatre and performance, and the reciprocity of theory and practice is emphasised throughout. The programme's work addresses critical themes including theatrical signification, space, adaptation, technology, scenography, documentation, devising, politics and identity. Its simultaneous focus on practice-based learning and on the theories, histories and contexts of contemporary theatre practice is highly distinctive.

The programme draws on the research interests of Birkbeck staff in contemporary performance and the professional practice and expertise of staff and associate artists at RADA. It enables students to study the relationship between the performance of a dramatic text and its theatrical, social and historical contexts. It provides a solid grounding in research methods and rigorous approaches to performance, which graduates may wish to build on by pursuing a PhD in a related area or practice in the creative industries. It takes full advantage of Birkbeck and RADA's proximity to London's West End theatre district and other performance spaces across the city for the study of theatre. Finally, it engages with the work of Birkbeck Centre for Contemporary Theatre and bespoke initiatives at RADA, offering opportunities for students to pursue extra-curricular performance-making and engagement with new scholarship.

### <sup>15</sup> Entry Criteria

Undergraduate degree at 2nd class honours or above, and/or relevant practical experience in the creative industries. All suitable applicants will be interviewed either personally or by telephone.

# International entry requirements:

If English is not an applicant's first language or they have not previously studied in English, the requirement for this programme is the equivalent of an International English Language Testing System (IELTS Academic Test) score of 7.0, with not less than 6.5 in each of the subtests.

## 16 Learning Outcomes

This will enable students to evaluate and critique rival methodologies, and, where appropriate, develop and propose new hypotheses and practices;
- 2. Demonstrate a systematic understanding of performance practice and a critical awareness of the current problems and new insights raised by the relationship between theory and practice;
- 3. Show an ability to develop practice-based approaches to dramatic texts.
- 4. Show an ability to discuss and analyse dramatic text in relation to the possibilities they offer for performance in the contemporary theatre, informed by a cogent grasp of the last half-century of theatrical history;
- 4. Demonstrate a sound grasp of the theatrical, intellectual and institutional contexts of contemporary theatre;
- 5. Demonstrate an ability to work collectively, and a reflective awareness of the context and dynamics of collective creation;
- 6. Demonstrate an understanding of the variety of approaches to the creation of performance practice that inform contemporary theatre practice;

#### [Intellectual]:

- 7. Show a comprehensive understanding of techniques applicable to their own research, advanced scholarship or theatrical practice;
- 8. Demonstrate originality in the application of knowledge and the development of practical projects, together with a practical understanding of how established techniques of research, enquiry and performance are used to create and interpret knowledge;
- 9. Deal with complex issues both systematically and creatively, make sound judgements in the absence of complete data, and communicate their conclusions clearly to specialist and non-specialist audiences;
