## 14 | Programme Rationale & Aims

This programme builds on the collaboration between the departments of HCA and Politics at masters level (via the existing MA Contemporary History and Politics).

The programme will provide students with a mix of skills drawn from the two disciplines: the ability to analyse data of different types, to understand the context and meaning of events, and to relate the study of the past to current political issues and developments.

## 15 Entry Criteria

For UCAS students, A-level qualifications of BBC or tariff-point-equivalent (112), with at least one A-level in either history or politics. Students who fail to achieve these grades may still be considered for entry if they demonstrate the required level of intellectual commitment and potential. The UCAS tariff score is applicable where applicants have recently studied a qualification that has a UCAS tariff equivalence.

We welcome applicants without traditional entry qualifications as we base decisions on our own assessment of qualifications, knowledge and previous work experience. We may waive formal entry requirements based on judgement of academic potential



## 16 Learning Outcomes

Students completing the BA Contemporary History and Politics will have:

- 1. demonstrated an ability to apply critically the main theories, concepts and approaches used in the analysis of historical topics, and in the analysis of political topics
- 2. demonstrated knowledge and understanding of:
- (a) a variety of social, political, cultural and intellectual changes in the period 1900-the present
- (b) the issues involved in current political debate
- (c) the nature of historical sources, their problems and potentials in providing access to the past
- (d) the conceptual tools used in political theory and practice

And (e) the shape of particular fields of historiographical and political academic discussion

- 3. extended and developed their analytical, evaluative and critical capacities
- 4. developed transferable skills, including the ability to take responsibility for their own learning, learning how to learn, making oral and written presentations, planning and producing written assignments in accord with basic scholarly standards, working independently and in groups, managing their time effectively and, where they have so chosen, using information technology relevant to their areas of study.

## 17 | Learning, teaching and assessment methods

Lecturers provide an overview of issues relevant to the subject being studied. Seminars mix tutor-led instruction with group discussion. They allow students to explore issues in depth and there is an expectation that all students will participate actively by reading recommended texts in advance and offering questions and viewpoints to the group. Where students work in areas related to their course, their experiences enrich discussion. Both lectures and seminars are used to develop subject knowledge and understanding, and to foster key analytical skills. The BA Contemporary History and Politics degree has been designed to guide and support students toward the attainment of the skills necessary to independent learning: by the end of their studies, students should be able to read critically, prioritise evidence, and present arguments coherently in written and oral forms. Teaching, learning and assessment modes are regularly reviewed in light of student feedback, student achievement, external examiners' reports, and peer monitoring. Students frequently consult staff outside formal teaching hours, often by email but also in person. Teaching is supported by comprehensive written guidance designed to support independent learning. A detailed course book for each module gives contact details of course tutors, describes intended learning outcomes and includes a course outline, schedule, recommendations for weekly reading, and essential information about course organization and assessment. Further materials are distributed in class, and guidelines on dissertations, revision and exam techniques are provided to students during the year. Assessment methods: A mixture of essays, reports, book reviews, and other written work and unseen written examinations across the taught modules. Essays enable students to read around a particular facet of a subject in depth; examinations provide an opportunity to test students' grasp of a wide range of material within a reasonably short assessment procedure. All students must demonstrate basic proficiency in both examinations and coursework. Provision is made for students with learning difficulties, health issues, or disabilities that may affect their ability to complete coursework and examinations. ## 18 | Programme Description

The programme consists of 360 credits: 12 modules of 30 credits each; or 10 modules of 30 credits each plus Writing the Past: Dissertation (60 credits). Students will take 120 credits at level 4, 120 credits at level 5, and 120 credits at level 6.

There are five compulsory modules: The Study of Politics (level 4), Comparative Government (level 4) and Exploring the Past (level 5)—these provide basic training in relevant study skills and essential disciplinary tools. At level 4 study, students must take The Modern World and The Contemporary World modules in History. Students must also take EITHER Contemporary British Politics (level 5) OR Transformations in Modern Politics (level 5). They also will take one option module in each discipline at level 5.

Students then have a choice of modules from both disciplines at level 6. Among those choices is the Writing the Past: Dissertation 60-credit module in History, and a choice of History documents-based 'Special Subject' modules. It should be emphasized that for this joint degree, these are available options and are NOT compulsory.

In each year of study, students will be required to take at least one module from each discipline.


