14	<b>Programme Rationale &amp; Aims</b>
	<p>This programme offers a unique insight into crime and punishment in today's world. It explores both cutting-edge criminological theory and current real-world phenomena related to crime and punishment. The programme provides a multidisciplinary platform for students to engage with the complexity of contemporary criminology, understand and critically assess the complexity of political, economic, social and cultural forces that affect crime and its control</p> <p>Those enrolled will be introduced to the theoretical debates that underpin understanding of the relationship between global, national and local questions of crime and punishment as well as race, gender, sexuality and migration. The diversity of the pathway options available aims to encourage students to think broadly and innovatively about questions of crime, punishment and the criminal justice system. They will also learn about the range of research methods that are used to explore such questions.</p>

17	<b>Learning, teaching and assessment methods</b>
	<p><i>Learning and Teaching:</i></p> <p>Learning will be primarily through face-to-face learning contact hours in each Module (compulsory and Options), supported by digital materials and online learning resources.</p> <p>For the Research Project, students are supported via 3 Tutorials for Research Project issues; a meeting with the Pathway lead to help refine ideas for the Research Project Proposal, and a minimum of three one-to-one supervision meetings with Project Supervisors.</p> <p>Moodle's online forum will also be used to provide students with appropriate materials and a space to share details of other pertinent publications and events.</p> <p>On the compulsory and optional modules, 1.5 hour seminars are used as the primary teaching format, though this will be supplemented with tutorials and supervision meetings throughout the year.</p> <p>Students are also able to attend the Criminology Seminar Series talks (3 to 4 events per term on Thursday evenings) and are encouraged to engage in a range of other School of Law events and workshops.</p>

	<p>Students also have access to a range of study skills workshops, online research and writing resources, and one-to-one sessions offered by the School of Law's two subject-specific Learning Development Tutors.</p> <p><i>Assessment:</i></p> <p>Students on the programme will engage with an array of assessment methods including theoretically focused critical reviews, longer essays focusing in particular optional subjects, an essay on research methodologies in criminology, a Criminology Research Project Proposal, as well as an 8,000 to 10,000 word Masters Research Project. The assessments in the compulsory modules are designed to help students work toward their final Research Projects.</p>

18	<p><b>Programme Description</b></p> <p>This MSc programme is for students who wish to pursue advanced criminological study. The programme provides a multidisciplinary platform from which students will engage with the complexity of contemporary criminology, understand and critically assess the complexity of political, economic, social and cultural forces that affect crime and its control. The pathway structure enables students to specialise in criminology and criminal justice; global criminology; gender, sexuality and criminal justice; or race, crime and justice.</p> <p>All students are required to take the following compulsory modules:</p> <ul style="list-style-type: none"> <li>(a) Research Methods in Criminology (30 credits)</li> <li>(b) Masters Research Project (Criminology) (30 credits)</li> </ul> <p>Students are required to undertake a research project that reflects their chosen pathway.</p> <p>All students are also be required to take:</p> <ul style="list-style-type: none"> <li>(c) A compulsory theoretical module designated for their chosen pathway (30 credits)</li> <li>(d) One pathway-specific option (from a list of designated options) (30 credits)</li> <li>(e) Two options (any option offered in law and criminology) (60 credits)</li> </ul> <p>There is an extensive list of optional modules to choose from. Students apply to the MSc Criminology, and then depending on their choice of options as outlined on the pathways below are awarded **MSc Criminology (Criminology & Criminal Justice)**, **MSc Criminology (Global Criminology)**, **MSc Criminology (Gender, Sexuality & Criminal Justice)** or **MSc Criminology (Race, Crime & Justice)** on successful completion of their programme.

The course will appeal to those with a keen interest in crime and criminal behaviour, as well as those seeking to develop a deeper appreciation and critical understanding of the key issues that currently play a major role in influencing criminal justice. It will also appeal to those who are seeking advanced knowledge and understanding of contemporary criminological theory and cutting edge research methods, as well as those who wish to pursue a substantial research project in an area that is of interest to them.
