¹⁴ Programme Rationale and Aims

Rationale: MA Film and Screen Media

The aim of the MA Film and Screen Media is to provide an advanced and leading edge course in the history and theory of film and related media. The compulsory module 'Screen Media: History, Technology and Culture' is designed to introduce students both to the historical, technical and cultural interaction between the main media forms - from precinematic forms through sound cinema, television and on to the internet, world wide web and the digital – and specific methodological approaches: historical contextualisation, close formal analysis and theoretical frameworks. The option modules offer students the opportunity to perform specific studies of aspects of the history and theory of film and related screen media which particularly interest them. The purpose of the work placement or research project is to provide students with direct industry experience, or an extended individual research period in which to conduct an empirical project. The reports written consequent upon this experience constitute a variable non-essay based writing experience. The work placement and/or research project also allows students to begin to orient their scheme of study towards particular interests and career plans. Finally, the dissertation, prepared over 6-8 months for part-time students and 3 months for full-time students, enables them to undertake substantial research, write an extended piece of work, and develop their personal time-management and self-motivation skills.

Distinctive Features

The programme is delivered both full- and part-time over one or two years, primarily during the evenings, but with some daytime attendance for full-time students, and in face-to-face study. A unique component on the taught MA programme is the opportunity for students to take up a two month placement at a company or institution involved in an aspect of the media. This gives them, across the whole period of the MA, the opportunity to acquire both academic and practical work experience, giving them the widest possible range of skills to take on to their future careers.

Rationale: MA Film and Screen Media (with Study Abroad)

MA Film and Screen Media (with Study Abroad) Media offers students the possibility to participate in a study abroad programme at one of our European partner institutions for one term in the Year 2. Students can also take a Level 6 language modules at the Department of Cultures and Languages in Year 1 to help them boost their linguistic competence in preparation for their term abroad in Year 2.

The creation of this pathway is possible thanks to the unique collaboration among a number of European institutions which are renowned for research and teaching excellence in the area of film and audiovisual studies. The length of the MA (2 years FT) and the level of commitment it demands from the student mean that the programme will be of particular interest to those students who are interested in research and likely to continue their studies further onto a PhD level. It is also likely to attract a different profile of a student from a typical Birkbeck student, i.e. a person who is not in full-time employment, and who has not yet embarked on a particular career path. The programme is likely to educate a new generation of academics and experts in film and audiovisual media whose research will benefit greatly from the international exposure and academic contacts offered by the pathway. The pathway will ultimately strengthen the College's international profile and allows to develop fruitful collaboration with the Department of Cultures and Languages.

Aims

The aims of the MA Film and Screen Media are to:

- Provide an advanced and leading edge course in the history and theory of film and related media
- Introduce students both to the historical, technical and cultural interaction between the main media forms from pre-cinematic forms through sound cinema, television and on to the internet and the web
- Introduce student to specific methodological approaches: historical contextualisation, close formal analysis and theoretical frameworks.
- Offer students the opportunity to perform specific studies of aspects of the history and theory of film and related media based on individual research interests
- Give students direct industry experience or an opportunity to conduct extended empirical research via the work placement or research project
- Allow students to begin to orient their scheme of study towards particular interests and career plans via the placement or research project
- Enable students to undertake substantial research, write an extended piece of work, and develop their personal time-management and self-motivation skills.

Rationale: MA Film and Screen Media with Film Programming and Curating:

The new pathway, MA Film and Screen Media with Film Programming and Curating, is a strategic integration of two related pre-existing programmes (MA Film and Screen Media and MA Film Programming and Curating) with the aim to consolidate those successful elements of our film and screen media provision at level 7 which are related to film history, archival and curatorial practice. The new initiative enables students to navigate a more considered and intelligible path of study that addresses specific research interests in film curatorial practice and exhibition cultures. It also encourages students, interested in gaining a specific film curating and programming expertise, to do so within the wider context of the MA Film and Screen Media related to history, theory and critical practice. Modules on exhibiting the moving image, film festivals and film curating have long proved a popular draw, and this new pathway formally recognises that interest in a more sustained and intellectually coherent way. Added to this, the pathway acknowledges the choices our students are already making, permitting them to better tailor their MA programme of

study in relation to future career development and/or doctoral study.

Aims:

The Pathway situates various aspects of film programming and curating within the intellectual framework of the MA Film and Screen Media. This pathway allows students to take full advantage of pre-existing modules that run across two distinct programmes (MA Film and Screen Media and MA Film Programming and Curating), enabling them to customise their course of study with an emphasis on film exhibition and archival practice. Students will also gain specialised knowledge of critical debates regarding curatorial, programming and archival practices during the compulsory module 'Programming and Curating: History Theory Methods', as well as by taking one of Film Programming and Curating modules. Students will become familiar with various ideas in relation to film programming, exhibition and curatorial practice, explored through a series of lectures (often with guest speakers and practitioners), seminars, site visits, oral presentations and written research work

Rationale: MA Film and Screen Media (with Television)

MA Film and Screen Media (with Television) is a pathway allowing students studying on the MA Film and Screen Media to develop expertise in the area of television cultures and cultural theory (in particular transnationalism and global TV cultures as well as digital cultures and platforms). The pathway enables students to navigate a considered and intelligible path of study that addresses the specific interests they have in television studies and global TV. The pathway situates various aspects of television within the intellectual framework of the MA Film and Screen Media. Students will become familiar with the various ideas in television theory, institutional histories and cultures of production and delivery, explored through a series of lectures, seminars, oral presentations and written research work.

The ability of applicants to think and write about the subject in meaningful and interesting ways is tested both by a short written exercise submitted with the application form and at interview.

All prospective students are interviewed, either in person or by telephone, after completing an application and written exercise. Interviews cover the nature and details of the MA programme, with the intent purpose of confirming its appropriateness for each applicant's interests and future plans (and vice versa) in terms of part-time or full-time study, the balance between physical attendance at taught sessions and personal research and study, and the various skills expected or to be developed in the student.

17	Learning, Teaching and Assessment Methods			
	The teaching format of the compulsory module "Screen Media: History, Technology and Culture" is a lecture followed by a 90-minute seminar, either that same evening (p/t), or the following afternoon (f/t). The compulsory module 'Programming and Curating: History Theory Methods' is taught in lectures and seminars lasting up to 3 hours. Option modules are taught in seminars lasting 2-3 hours, which may begin with short introductory lectures.			
Lectures present an overview of the salient issues attached to the week's subject area pointing students in the direction of required reading and viewing of additional audio- visual materials, as well as further reading, research and viewing materials. Handouts designed to facilitate this, directing students towards supplementary information. Seminars then allow students to discuss both the required reading/viewing and the re of personal research and study, as well as allowing them to experience the formal presentation of ideas to their peers. Further support and expansion of areas of interes come in the form of weekly tutorials, where students can discuss issues with lecturers one-to-one basis.

Pathway: The structure of the MA Film and Screen Media with Film Programming and Curating is:

Full-time students take the compulsory modules 'Screen Media: History, Technology and Culture' and 'Programming and Curating: History Theory Methods' and one option module in the autumn term, a second option module in the spring term, and either the work placement module or the research project module in the summer term, and work on their dissertation from the spring term through to the end of September.

In Year 1, part-time students take the compulsory modules 'Screen Media: History, Technology and Culture' and 'Programming and Curating: History Theory Methods' in the autumn term, one option module in the spring term, and either the work placement module or research project module in the summer term and through to the beginning of September. In Year 2 they take the second option module in the autumn term, and work on their dissertation from the spring term to the end of the programme at the end of September.

Students will qualify for the pathway by completing at least 105 credits involving the following: option modules chosen from a pre-selected list of film programming and curating related courses and Dissertation, with an emphasis on film programming and curating. In addition, students must complete the MA FSM core course, the compulsory module 'Programming and Curating: History Theory Methods', placement / research report.

The structure of the MA Film and Screen Media (with Television) is:

Students take the compulsory module 'Screen Media: History, Technology and Culture', two option modules, either a work placement module or a research project module, and a core dissertation.

Students will qualify for the Pathway by completing at least 90 credits involving the following: 1 x module chosen from a pre-selected list of television courses (30 credits) and a dissertation, with emphasis on television (60 credits).

Full-time students take the compulsory module 'Screen Media: History, Technology and Culture', and one option module in the autumn term, a second option module in the spring term, and either the work placement module or the research project module in the summer term, and work on their dissertation from the spring term through to the end of September.

In Year 1, part-time students take the compulsory module 'Screen Media: History, Technology and Culture' in the autumn term, one option module in the spring term, and either the work placement module or research project module in the summer term and through to the beginning **of** September. In Year 2 they take the second option module in the autumn term, and work on their dissertation from the spring term to the end of the programme at the end of September.

'Screen Media: History, Technology and Culture' is designed to introduce students to the basic methodologies and issues involved in the area concerned, as well as research skills and methods.

Option modules allow students to pursue specific interests and areas of research, in this case television.

The research project gives students the chance to undertake independent research in the area of contemporary film and media practice and reflect on research methodologies.

Students will complete the Pathway with a 15,000-word dissertation with emphasis on television.
