Admissions requirements

2.2 degree in a relevant subject (other arts and humanities) or equivalent (for example, professional experience).

For students with a degree in a not relevant subject, the one-year part-time Graduate Certificate in History of Art and Architecture can be used as a conversion course. Students who successfully complete the Graduate Certificate with Merit will be guaranteed a place on this programme.

We welcome applicants without traditional entry qualifications as we base decisions on our own assessment of qualifications, knowledge and previous work experience. We may waive formal entry requirements based on judgement of academic potential.

Course aims

Our MA History of Photography with Curating investigates historically how photography has become the major form of image-making and visual communication since its development in the nineteenth century. Its importance has been recognised in many areas of scholarship: history of art, media and cultural studies, literature, memory and memorialisation, gender and identity, philosophy and law. Its role in all fields of the arts and sciences, including those most personal, is being expanded, renewed and questioned by contemporary digital cultures. This MA aims to:

- help you acquire high-level foundational skills and a solid grasp of key issues in curating
 practice. You will gain an insight into the different working practices of various museums
 and galleries and a broad understanding of the role and responsibilities of the curator
 within the modern museum and gallery context.
- expose you to key art historical approaches and enable you to learn about and to
 negotiate your individual path through past and present photographic practices and
 cultures, in order to develop your interests, whether your engagement with the medium
 is academic, artistic, personal or vocational, in early, modern and contemporary art,
 through taught options and independent research.
- develop your visual acuity and your understanding of art's histories, while stimulating
 critical debate and stretching your research skills. We teach History of Photography as a
 rich and dynamic discipline, combining the rigorous investigation of the visual arts with
 the creative exploration of their connections to culture, politics and society. Postgraduate
 study in this area trains you at a high level in looking at, thinking about and researching
 photographs and their histories.
- offer you the opportunity to study with internationally recognised experts. Our teaching staff are defining the field, conducting groundbreaking research in the history and theory of photography in its various uses and manifestations, and offers you the opportunity to learn with other specialists on the history of print culture, architecture, painting, sculpture, digital art and museology. You will work closely with our staff while also benefiting from our diverse and vibrant student body of all ages and backgrounds.
- develop subject-specific and transferable research, critical and writing skills that will
 enhance your career opportunities in the field and beyond, whether in academia or
 teaching, photography as a practice, galleries and museums, or in the media. The
 course is also ideally suited to preparing students with a practice-based background
 considering a PhD, academic or practice-based.

During an intensive week studying current issues and practices in curating you will meet curators and collections managers in London's thriving museum, galleries and archives

sector, and engage in hands-on activities including documentation, cataloguing and issuing loan requests.

Our teaching programme is enriched by museum and site visits, visiting speakers, study trips, and research events organised by the History and Theory of Photography Research Centre. You can take part in visits to photographic archives and exhibitions, and take advantage of placement opportunities in the. You will also have the opportunity to apply for a 10-week supervised work placement in a museum, gallery or archive, including our Jo Spence Memorial Library and Archive. Previous work placements have been offered at the Tate, British Museum, Whitechapel Gallery and Horniman Museum. Past students have documented collections that were previously uncatalogued, helped design and run schools programmes, conducted visitor research and assisted curators in producing exhibitions.

Many of our graduates progress to careers in arts-related fields or undertake further postgraduate work.

How you will learn

Your learning and our teaching are organised to help you meet the learning outcomes of the course indicated below. As a student, we expect you to be an active learner and to take responsibility for your learning, engaging with all of the material and sessions arranged for you.

The course is divided into modules. You will find information on the virtual learning site (Moodle, see Academic Support below) about each of your modules, what to expect, the work you need to prepare, links to reading lists, information about how and when you will be assessed.

Your learning for this course will be organised around the activities outlined below.

The majority of our sessions are seminar-based, which means you are expected to come having done the reading or other preparation required, which is also essential to engage with and progress through the course. The seminar component of each session enables you to explore ideas and methods, to discuss both the required reading and the results of your personal research and study, and to refine your own skills of argument, communication and presentation. Seminars may include structured or open debate, a close analysis of textual or visual material, small group discussions and task-based work. Classroom based work is supported and enhanced by visits to archives, museums and galleries.

The curating module is taught over one intensive week, morning in class and afternoon on visits, field trips and workshops. You will meet curators and collections managers in London's thriving museum, galleries and archives sector, and engage in hands-on activities including documentation, cataloguing and issuing loan requests. You are expected to have done all the preparatory reading and some of the set work on an exhibition proposal in advance.

As the MA progresses you are expected to become increasingly an independent researcher. This is reflected in the fact that both the research exercise and dissertation are largely self-defined rubrics with guidance from academic members of staff.

Further support and expansion of your areas of interest comes in the form of opportunities to present and discuss with your lecturer and peer-group ideas and plans for essays, the research exercise (or the work placement essay) and the dissertation. Work on the dissertation is further enhanced by work-in-progress seminars in the summer term.

Research seminars, symposia and lectures delivered by relevant guest speakers provide students with an opportunity to engage with current developments and debates in the field.

How we will assess you

The course will use a variety of assessment methods. Assessment is used to enhance your learning rather than simply to test it. For most of the modules associated with this course, your assessment will be through essays which will develop in length and expected complexity as you progress through your studies.

Learning outcomes (what you can expect to achieve)

'Learning outcomes' indicate what you should be able to know or do at the end of your course. Providing them helps you to understand what your teachers will expect and also the learning requirements upon which you will be assessed.

At the end of this course, you should be able to:

- Demonstrate you have knowledge of current theoretical and historiographic issues in the study of history of photography, especially in its relation to art history
- Demonstrate postgraduate level acuity in observing visual culture especially in relation to photography
- Demonstrate you have developed an enhanced understanding of this visual culture within the social and cultural context of its production
- Engage constructively in current debates concerning photography and its changing cultures and roles in society.
- Reflect on the process of research and to demonstrate how research questions and projects relate to the state of knowledge in the field

Intellectual

- Research, select and acquire relevant visual and textual material and evidence and to analyse, present and interpret this as appropriate within the context of the course
- Research, select and develop appropriate historical and theoretical methodological frameworks and approaches
- Understand advanced abstract material and demonstrate critical awareness and distance

Practical

- · Undertake short and extended-length academic writing
- · Communicate ideas effectively, both in writing and verbally

You will be also assigned a personal tutor you can contact to discuss your general progress on the course, or to seek help accessing other forms of support.

Quality and standards at Birkbeck

Our periodic review process is a regular check (usually every four years) on the courses by department with a specialist team including students.

Each course will have an external examiner associated with it who produces an annual report and any recommendations. Students can read the most recent external examiner reports on the course Moodle pages. Our courses are all subject to Birkbeck Baseline Standards for our Moodle module information. This supports the accessibility of our education including expectations of what information is provided online for students.

The information in this programme specification has been approved by the College's Academic Board and every effort has been made to ensure the accuracy of the information it contains.
