#### **Admissions requirements**

We welcome applicants with a wide range of previous experience and qualifications. A second class honours degree (2.2 or above) in a Humanities subject satisfies the standard requirement, but we do base decisions on our own assessment of qualifications, knowledge and previous work experience. We may request writing samples or further interview to gauge academic potential in instances where non-traditional education and experience may merit the waiving of formal entry requirements.

#### Course aims

The practise and importance of 'public history' has grown significantly in recent years, as academic historians have become more aware of audiences beyond the academy, of the role of history in politics, of the need for academic work to have public 'impact', and of the growing public and media interest in heritage and popular history. Public history training is seen as a valuable qualification for employment in the heritage, museum, and tourism sectors, in policy and research work, in education, and in media. Birkbeck's MA Public Histories aims to provide students with valuable training to pursue work in those sectors, to provide masters-level research training that would enable them to continue on to PhD study, and to provide them with the critical academic and intellectual skills necessary to assess and create public history projects and interventions. Drawing on the pre-existing research and impact strengths of the Department of History, Classics and Archaeology, and working with the MA in Museums Studies at the Department of Art History, our programme aims to give students a sense of the wide range of public history, the variety of roles played by historians beyond academia, and the importance and impact of public history in politics, culture, and society.

### How you will learn

Your learning and teaching is organised to help you meet the learning outcomes (below) of the course. As a student, you are expected to be an active learner and to take responsibility for your learning, engaging with all the material and sessions arranged for you.

Each course is divided into modules. You will find information on the virtual learning site (Moodle, see Academic Support below) about each of your modules, what to expect, the work you need to prepare, links to reading lists, information about how and when you will be assessed.

Your learning for this course will be organised around the activities outlined below.

Teaching on this course includes lectures but is predominantly structured as seminars, or discussion-focused group sessions. In the introductory module 'Mastering Historical Research: Birkbeck Approaches', lectures from our internationally-recognised staff will introduce you to critical ideas, debates and figures of the past, while seminars in this and subsequent modules will train you in the construction of collaborative knowledge alongside the diverse community of your fellow students. You will also deepen your subject knowledge and sharpen your critical skills through extensive reading and other forms of independent learning. Modules across the programme include the analysis of primary and secondary text sources, as well as of images, material culture, music and film.

#### How we will assess you

The course will use a variety of assessment methods. Assessment is used to enhance your learning rather than simply to test it. For most of the modules associated with this course, your assessment will be through the following types of assessment.

History modules normally incorporate diverse forms of assessment, including shorter, mid-term written exercises such as source analyses or literature reviews; oral presentations; and end-of-

module research essays. Assignments grow in complexity across the term, offering the reassurance of guided progression towards the research essay, and tailored writing support is available within the department and at college level for students who might benefit from additional advice. To complete the degree, you will design, research, and write a dissertation.

#### Learning outcomes (what you can expect to achieve)

'Learning outcomes' indicate what you should be able to know or do at the end of your course. Providing them helps you to understand what your teachers will expect and also the learning requirements upon which you will be assessed.

At the end of this course, you should be able to:

- Apply knowledge and skills gained to employment in the media, tourism, heritage, museums, and policy sectors.
- Understand the wide-ranging practise of public history and be able to comment critically upon existing projects, interventions, and practises.
- Understand the key debates surrounding public history and the role of the public historian
- Understand how history is used and disseminated in the media and on the internet; how
  museums and archives engage in public history; the role of public history in the heritage
  and tourism industries; the way in which policy makers engage with history and
  historians contribute to public policy debates; and the role that history plays in
  community development and community-based projects
- Prepare written critiques of existing public history projects and interventions
- Design a successful and critically engaged public history projects or interventions
- Engage critically with current historiographical debates about Public History
- Gain an awareness of contemporary historical practice

#### **Careers and further study**

The MA Public Histories prepares you for any role which benefits from skills in research, communication and engagement. Graduates of our programme work most commonly in the heritage, museum, and tourism sectors, in policy and research, in education, and in media, but others work across a wider range of public-facing professions, including business, the arts, and non-governmental and charitable organisations. Graduates interested in further study have gone on to complete research degree (MPhil/PhD) programmes.

Birkbeck's MA Public Histories graduates will complete with a set of valuable attributes, for example:

- The ability to work as part of a team
- High-level oral and written communication skills in English
- Research skills
- Skills in evaluating and assessing types of information
- The ability to present yourself and an argument to a range of audiences

## **Quality and standards at Birkbeck**

Birkbeck's courses are subject to our quality assurance procedures. This means that new courses must follow our design principles and meet the requirements of our academic regulations. Our periodic review process is a regular check (usually every four years) on the courses by department with a specialist team including students.

Each course will have an external examiner associated with it who produces an annual report and any recommendations. Students can read the most recent external examiner reports on the course Moodle pages. Our courses are all subject to Birkbeck Baseline Standards for our Moodle module information. This supports the accessibility of our education including expectations of what information is provided online for students.

The information in this programme specification has been approved by the College's Academic Board and every effort has been made to ensure the accuracy of the information it contains.
